The Republic of Kosova has received financing from the Saudi Fund for Development (SFD) toward the costof Upgrading the Milloshevë - Mitrovicë M2 Main Road Project, and it intends to apply part of the proceeds toward payments under the contract for Consulting Services for the Design Review and Construction Supervision of the Upgrading Milloshevë - Mitrovicë M2 Main Road Project, from 7+165km to 16+946.5km (a length of 9.78km). The objective of the assignment is to carry out detailed design review, procurement of civil works contractor, supervision and monitoring of physical progress, quality and the financial status of the construction works with the objective to ensure that the works are completed on time, meet the engineering specifications, social, environmental and road standards.

The services are expected to cover twenty-five (25) calendar months period from the commencement date. It comprises of, 3 months, review of design, preparation of the tender dossier, procurement procedures and evaluation of bids, 20 months construction supervision period and 2 months project finalization period.

The civil works consists of upgrading the existing road from a single carriageway to a separated dual 2-lane carriageway, each with 3.75m width, emergency lanes on the both side with the width of 2,0m and other road side facilities. The design speed of road is 60-100km/h.

The Ministry of Environmental Spatial Planning and Infrastructure (Executing Agency) through Project Management Unit (PMU) now invites eligible consultants to indicate their interest in providing the required services. Interested Consultants should provide information demonstrating that they are fully qualified; have required qualifications and relevant experience to perform the consulting services. The selection criteria of the consultants will be based on the following:

- Organizational structure showing key departments to perform the required design review, quality control and supervision services.
- The candidate has provided services in at least three contracts/projects in supervision of a highway/dual carriageway, (including one major bridge structure), in a length of at least 12km with a budget at least 500,000,00 Euro for the last five years from 2017 to 2022 (at least on contract/project being in Balkan Region). Supervision services to have included design review.
- The candidate to have at least 12 permanent staff working for the candidate in fields related to the contract (Supervision/Management of Works / Design Review).
- The average annual turnover of the candidate for last three years (2020, 2021 and 2022) must be must be at least 5,000,000.00 Euro.

Consultants may associate with other firms to form a joint venture or sub consultancy to enhance their qualifications. The Expression of interest must clearly indicate the type of intended association as joint venture or sub consultancy and the lead firm in the Expression of Interest.

A consultant will be selected in accordance with the Quality and Cost Based Selection with the procedures set out in <u>the Guidelines for the Use of Consultants under Saudi Fund for Development Financing</u>. Consultants may express interests in the forms of association, validated by an agreement among members of the association which clearly specifies the type of association, i.e. a joint-venture, intermediate forms of association, or sub consultancy. International companies may apply with a preference given to Saudi companies with a local partner.
